Reflections on the Graduate Program Over the Past 20 Years

As mentioned by Dr. Warren, I stepped down this past summer after serving nearly 20 years as Graduate Program Director. It has been my great honor and pleasure to have worked with so many of you during this time. And we are so fortunate to have such a large, outstanding, and diverse faculty and excellent staff. I truly believe that our successes over the years are primarily due to the people – strong support from Deans McLeran, Johnsen, and Hand, our great faculty and staff, and exceptional students! And we have Dr. Warren's great leadership already helping the program toward new levels of excellence!

Since most of you were here only for 2-3 years (or 4-5 years if pursuing the PhD), I'd like to make a few more observations:

- Our program has become stronger over the years through increased student diversity:
 - The number of trainees has increased from 1 every year or two to 3-4 each year.
 - There were almost all U.S. students in the program's first 20 years, but about half have been international students more recently.
 - We have had a number of joint DPH/Pediatric Dentistry trainees since 1996.
 - We have become a key part of the Oral Sciences PhD program, with DPH trainees constituting about half of total trainees.
- Our program has matured, with:
 - More departmental and graduate program seminars,
 - Affiliation for 2-3 courses per student taken in the College of Public Health,
 - The majority of graduates having manuscripts published on their thesis research, and
 - More in-depth field training experiences.
- We have been fortunate to have successfully applied for and received several cycles of federal DPH specialty training grant support, following about 20-25 years of no such programs being available. This has provided critical tuition and stipend support for student trainees, as well as allowed us to have regional fall DPH conferences most years of the past 10 years.

A NOTE FROM THE GRADUATE PROGRAM DIRECTOR ~

As of July 1, 2010, I became director of the Graduate Program in Dental Public Health, stepping into the shoes of Dr. Steve Levy, who was graduate program director for nearly 20 years. My first reaction to this change is best summed up by the immortal words of Groucho Marx, "if these are your shoes, the least you could do is have them cleaned." I soon realized that taking over the graduate program did not

mean that I had to literally take over Steve's office, and I was much relieved.

In all seriousness, I am humbled by the responsibility of taking over a dynamic and successful program and following Steve in this capacity. As some of the more senior alumni of the program (like me) will attest, the program during the 1980s was very small, with perhaps one or two new students per year. And that was in a good year – there were years when there were no new graduate students. Since 1990, when Steve took over directorship, enrollment has increased substantially to the point that ours is among the larger graduate programs in the College of Dentistry. There have also been several new initiatives, including the Oral Sciences PhD program, which has had a substantial proportion of its students with DPH emphasis; the joint Pediatric Dentistry/Dental Public Health program, along with a less formal joint program with Operative Dentistry; and finally, the new combined DDS/MS in Dental Public Health program highlighted elsewhere in this newsletter. Taken together, these are remarkable accomplishments, and because of these accomplishments, the graduate program has reached new heights and is now at the pinnacle of DPH programs. Well done, Dr. Levy!

Since the program is currently in such "good shape", I do not anticipate any substantial changes in the immediate future. However, I well understand that change is inevitable and that simply maintaining the status quo can be a recipe for failure, so I am sure that the program will continue to evolve. The cynic in me also knows that with the program at the top, there is only one way to go – down. I am confident this will not occur, primarily because we have a great team of leaders here that I can depend upon for support and guidance. I am fortunate that Steve Levy will continue to be actively involved in the program (no, he's not leaving or seriously ill), as will Ray Kuthy and others.

I look forward to the challenges and rewards that lie ahead, and wish all of you the best for 2011!

- We have recent special arrangements for U.S. Army DPH trainees to train with us, along with U.S. Navy Operative/DPH joint trainees.
- A number of graduates have won AAPHD Leverett Graduate Student awards.
- The national reputation of our program has been enhanced substantially through these many accomplishments of the program and trainees!

In summary, I am so fortunate that I had the opportunity to help lead this program. I'm very proud of the work we have done together, and all of your accomplishments. You are very important leaders in Dental Public Health individually and collectively, and I look forward to our future interactions, challenges, and successes.

Dr. Bishara died a few weeks short of his 75th birthday, and had been battling lymphoma for some time prior to his passing. While not a member of the department or program faculty, Dr. Bishara collaborated on several projects and grants with me and others in the department, most notably aspects of the Iowa Fluoride Study involving growth and development. He worked with several of our graduate students on various research projects and also was involved in teaching and clinical care for pre-doctoral and graduate students in Orthodontics and Pediatric Dentistry. His energy, dedication to students, and mentorship will be greatly missed.

Building Update from the Chair

- Building Expansion Update -

The College of Dentistry building project is on schedule, including both Phase I (the new 30,000 square foot addition) and Phase II (renovation of the existing south building). We hope to be installing equipment in the new addition in September 2011 with plans for occupancy in October. Planning for renovation of the south wing is in full

swing as well -- bidding for the project is expected to go out in November 2011 for a December or January start. Phase II will likely take a few years to complete.

Whether you're a graduate of our MS program in Dental Public Health, an alumnus of our joint program with Pediatric Dentistry, or had an emphasis in Dental Public Health as part of your PhD program in Oral Sciences, the Department of Preventive and Community Dentistry is happy to provide you with an outlet for your philanthropic side. We feel especially left out of the building project because the addition and renovation phases are only for the south building, and all the offices for our department's graduate students, faculty and staff are located in the north building! Like our neighbors to the south, we'd love to join in the fun and bring our humble home into the 21st century. (Note: Our graduate student office was recently moved from the south side to the north side of the building, in an area that puts the students in close proximity with department faculty and staff.)

Accreditation

The graduate program in Dental Public Health be reviewed by the ADA's Commission on Dental Accreditation (CODA) in September 2011, as part of the accreditation process of the College of Dentistry, which occurs every seven years. This process will entail documentation of program activities and operations, as well as a site visit by a board-certified public health dentist appointed by CODA. We are required to document some information regarding alumni, so please be aware that we may need to contact you for these purposes. Thank you.

Ongoing Dental Public Health Training Grant

We are currently in our second year of our 3-year Dental Public Health (DPH) specialty training grant from the federal Bureau of Health Professions (BHPr) of the Health Resources and Services Administration (HRSA) within the Department of Health and Human Services (HHS). We were fortunate to have similar grantfunding earlier from 2000-2004 and 2006-2009. These grants have provided: 1) tuition and limited stipend support for graduate student trainees; 2) partial support for field training experiences, thesis research, and sometimes travel to Dental Public Health meetings such as the National Oral Health Conference (NOHC)/Annual Meeting of the American Association of Public Health Dentistry (AAPHD); 3) support for our fall regional DPH conferences; and 4) limited faculty and staff support. There typically are 2-3 trainees supported by the grant at any time. (Only U.S. citizens and permanent residents are eligible.) We hope that the program will continue so that we are able to compete for a renewal grant in about 18 months.

New DDS/MS Training Grant

The University of Iowa College of Dentistry has received a 5-year training grant from Bureau of Health Professions, Health Resources and Services Administration, U.S. Department of Health and Human Services, to develop and implement a new combined training program in general dentistry and the specialty of Dental Public Health. Dental Public Health is one of the nine dental specialties, as recognized by the American Dental Association. There is need for such innovative programs because there is a shortage of Dental Public Health specialists both regionally and nationally. The grant is from 9/1/10 to 6/30/15 and will support trainees in a program that combines both the Doctor of Dental Surgery (DDS) and Masters Degree (MS) in Dental Public Health simultaneously. This combined program, which will take about 5 years to complete, will integrate coursework from the two degree programs which normally take 6+ years to complete if done separately. The funding is \$196,623 for the first year and \$1,781,934 over the five years, with the majority going to support trainee expenses and stipends. Ms. Julie Reynolds is a current D4 student who is taking DPH courses with us and is receiving support from the grant. She plans to be a full-time DPH graduate student next year.

The Principal Investigator is Dr. Steven M. Levy, Wright-Bush-Shreves Endowed Professor in the Department of Preventive and Community Dentistry (College of Dentistry) and Professor in the Department of Epidemiology (College of Public Health). Co-investigators are Dr. Raymond A. Kuthy (Professor, Department of Preventive and Community Dentistry), Dr. John J. Warren (Professor, Department of Preventive and Community Dentistry), Dr. Michelle R. McQuistan (Assistant Professor, Department of Preventive and Community Dentistry), Cathy A. Solow (Associate Dean for Student Affairs), and Dr. Rick D. Axelson (Assistant Professor, Department of Family Medicine, College of Medicine).

Regional Dental Public Health Conference

On October 17-18, 2010, 65 Dental Public Health professionals from 9 states met in Coralville, Iowa to address this year's theme (Dental Home). The title for this sixth conference was "Oh, Give Me a Home...": Revisiting the Dental Home for Children". Unlike previous conferences, we decided to have two major presentations. Harry Goodman, Director, Office of Oral Health, Maryland Department of Health and Mental Hygiene, provided the keynote address (A Dental Home Is Where the Heart Is), while Jody Murph, Department of Pediatrics, University of Iowa spoke about the medical home (The Medical Home: What It Is: What It Isn't; and Why It's Important to Children's Health). Both presentations stimulated extensive discussion among the conference attendees.

Eight states provided information concerning programs that are currently underway concerning dental home initiatives, including the regional effort between the American Academy of Pediatric Dentistry and the Office of Head Start. Examples of other activities included an update about the I-Smile program in Iowa, the Kansas Cavity Free Kids program (targeted at Head Start program), South Dakota's Caring for Smiles program (primarily for children with disabilities), and Missouri's Ready Smile Project (a case management system in the Kansas City area). In addition, Jeff Chaffin provided an update about the TriCare dental insurance program for military dependents and retirees. As always, this forum provided an opportunity for the University of Iowa DPH graduate students to engage with program directors for several Dental Public Health state and local programs in the Midwest.

The goal of these conferences, which have been supported through grants by Health Resources and Services Administration and several Delta Dental organizations (Iowa, Wisconsin, Minnesota, South Dakota), is "to facilitate attendees' networking and knowledge concerning access to dental care for children at the state, local, and national levels as they pertain to the Midwest." The tentative theme for the next conference is oral health workforce.

Course Change

For the past decade, graduate students enrolled in two semesters of Dental Public Health field experience. The first semester is primarily devoted to visiting and interacting with at least three public or non-profit organizations; whereas, during the second semester students work with an off-site mentor on mutually agreed upon programmatic objectives for that organization. Both of the semesters used the same course number (111:208 – Field Experience: Dental Public Health). Based on student feedback concerning the appearance that the student took the same course twice, we petitioned the Graduate College to now have two distinct course numbers. The second semester is now designated as 111:209 – Advanced Field Experience: Dental Public Health.


Linda Saleh ('06) has recently moved to Jeddah, Saudi Arabia with her family.

Atul Bidarkar - *Portable dental equipment: findings and recommendations for the Barren River District Health Department (Kentucky)*

Site Director: Stacy Towbridge (Barren River District Health Department)

The goal of this project was to provide this new oral health program, which serves eight counties in southcentral Kentucky, with a detailed business plan comparing portable dental equipment versus a mobile dental van.

Adrienne Jennings - *Iowa dentists and how they relate to public health functions*

Site Director: Bob Russell (Iowa Department of Public Health)
Since little is known about the public health beliefs of dentists and how
they incorporate these beliefs into their practices, this project centered
on the creation and implementation of a survey instrument that was
administered to 300 Iowa dentists.

Deise Oliveira - Muscatine Children's Oral Health Clinic: a Follow-up Site Directors: Richard Burke (UI Pediatric Dentistry), Michael Kanellis This project primarily focused on parental satisfaction survey with services provided at the Muscatine Center for Social Action dental clinic, which was in its fifth year of operation. In addition, local dentists participated in a parallel survey to determine about their knowledge about this facility and whether they referred patients to this clinic. Findings are being used to improve patient services.
